Information regarding processing of data

The German Society for Semiotics (DGS) collects the above data within the framework of the fulfillment of the association's statutory purpose. Should you require a particular manner or degree of confidentiality with respect to any of the above data, you may communicate this to the association. This information will be saved and maintained (in altered form) in the computer system by the executive office. The personal data will be protected via suitable technical and organizational measures by your selected third party. Access to the data is restricted to members of the executive board and other members with particular functions that require knowledge of member data. These parties are obligated to protect the privacy of member data. Compliance is voluntary. **If you do not consent, you cannot be a member of the DGS.**

Upon withdrawal from the society, all member data will be deleted from the member list.

The following data will be transmitted to a publisher for consignment of the "Journal of Semiotics" periodical: title, first name, last name, and complete address (indicated as recipient for the delivery of the journal). The publisher will be instructed to your use data only for the delivery of the journal and to delete that data following delivery.
